



NVIH POSITION DESCRIPTION

LEAD MEDICAL PROVIDER

REPORTS TO: Medical Director

SUPERVISES: Midlevel Providers at designated site(s)

POSITION SUMMARY: In addition to providing medical services to assigned patients, the Lead Medical Provider will provide overall supervision to the other medical providers.

RESPONSIBILITIES:

1. Provide direct medical services to program patients.
2. Provide assistance in establishment, review and revision of Medical Department protocols, policies and procedures.
3. Assist in establishing and maintaining professional relationship with ancillary medical, laboratory and pharmaceutical services within the community.
4. Evaluate abnormal laboratory studies, X-rays and other tests and prescribe treatment as necessary.
5. Evaluate patients with complex problems and refer to appropriate specialists if problem cannot be treated in-house.
6. Work in conjunction with other Medical Clinic personnel in providing ongoing health education and information on preventative medicine.
7. Participate in providing initial obstetrical services and refer patients for obstetrical care and delivery.
8. Assist with approving paid time off for medical providers at designated site(s).
9. Attend meetings as assigned
10. Be involved in recruiting efforts as appropriate
11. Assist Clinical staff in quality assurance and peer review.
12. Responsible for obtaining necessary continuing medical education credits. A significant portion of which should be specifically relevant to Indian Health issues.
13. Keep medical license, DEA registration and CPR certification current.
14. Maintains the standards of patient care and implements the policies and procedures of the Medical Department.
15. Responsible for communicating problems identified involving personnel, medical staff, patients, families and the general public to the Clinic Manager.
16. Other duties as assigned by Medical Director.
17. In cooperation with the Medical Director, perform annual performance reviews of Medical providers at designated site(s) as assigned.
18. In cooperation with Medical Provider, use policies to deal with patient complaints at the designated site(s).
19. Perform peer review for medical providers as assigned.

21. Provide consultation for mid-level medical providers as needed.

QUALIFICATIONS:

1. Licensed California Physician (Board Certified in Family Practice preferred). Out-of – state license is accepted, but must be able to obtain California license within one year.
2. Two (2) years clinical experience in direct delivery of primary care.
3. Sensitive to Indian culture and health needs.
4. Current DEA registration.
5. Current CPR card.
6. Indian preference. Preference in filling vacancies is give to qualified Indian candidates in accordance with the Indian Preference Act (Title 25, U.S. Code, Section 472 & 473). In other than the above, NVIH is an Equal Opportunity Employer.

LANGUAGE SKILLS: Ability to read, analyze, and interpret the most complex documents. Ability to respond effectively to the most sensitive inquiries or complaints. MATHEMATICAL SKILLS: Ability to apply advanced mathematical concepts such as exponents, logarithms, quadratic equations, and permutations. Ability to apply mathematical operations to such tasks as frequency distribution, determination of test reliability and validity, analysis of variance, correlation techniques, sampling theory, and factor analysis.

REASONING ABILITY: Ability to apply principles of logical or scientific thinking to a wide range of intellectual and practical problems. Ability to deal with nonverbal symbolism (formulas, scientific equations, graphs, musical notes, etc.) in its most difficult phases. Ability to deal with a variety of abstract and concrete variables.
